I understand that I am solely responsible for manning my own booth and making my own sales, as well as the collection and reporting of sales tax to the appropriate agencies. I agree to make no claim, for any reason whatsoever, against "Sage & Songbirds Festival", CHIRP for Garden Wildlife, Viejas Enterprises, or any other person, persons, or organizations affiliated with the Festival, for loss, theft, damage, destruction or non-delivery of goods, display materials or their effects; nor any injury to myself or my representative, before, during or after the Festival. *As a courtesy to our environment, we ask that you not distribute latex balloons.*
